Bills that may be relevant for our neighbors:

- Georgia's Heartbeat Bill
 - \circ $\;$ This is an initiative led by Georgia Governor that would effectively outlaw abortion in Georgia.
 - $\circ~$ Passed senate bill and will go to senate floor for vote, then moves to house due to revisions.
- Bill 316
 - This bill is proposed to change the way voting is done in Georgia.
 - The bill involves finances to purchase new voting machines that print out cast ballots with a barcode.
 - The change would cost \$150-400 million.
 - Paper ballots will cost ~\$20 million and may be more secure, according to some experts.
- Medicaid waiver bill
 - Concerns with this bill involve covering fewer Georgians (200k Georgians) for large costs (~\$900-million).
 - An alternative could be to expand Medicaid for more coverage and less cost.
- Bill proposed to protect all existing statues
 - The proposal states that cities and counties cannot remove statues of any kind.
- Annexation
 - City of Decatur purchased United Methodist Home, and there is a proposal for 12 total properties (including the home) to annex.
 - The concern is that 1 person owns 6 of the 12 properties, and that property owner is not in favor of annexation due to a drop in property value; he wants a rezoning prior to indicating his support.

- Looking to implement policies for annexation, including an impact study and lead time for proposal submission (i.e., 2 months prior to session).
- Medical Marijuana bill
 - Concerns regarding lack of underrepresented minority participation and access to medical marijuana.
- Other bills sponsored (longer timeline for passing):
 - Non-discrimination ordinance
 - Marijuana possession as a ticketable offense
- Dekalb delegation meetings
 - Every Monday at 12 PM in Capital Room 216
 - Everyone is welcome to attend.
- City bills
 - $\circ~$ Impact study is needed to better understand how city conversion will impact counties.
- Question from our group regarding senior exemptions no word on possible extensions, and it will be revisited closer to the time of expiration.

Flock Security Cameras

- Rhea Craig and Lee Pritchard attended on behalf of the neighborhood.
- Flock is a subscription service for cameras that scan license plates as cars come into and out of the neighborhood for up to 2 weeks.
- It has a searchability feature for make of car, time of day, license plates, color of car; night photos of high quality.

- Require a police or gatekeeper to review scans, and gated communities and areas of high crime tend to use it.
- Cost: \$2000/camera/year
- Not much support for Flock in Glennwood Estates.

Decatur Prevention Initiative and Decatur Parents Network

- Purpose of these organizations is to promote a healthy Decatur, free of negative effects of alcohol and other drugs on youth and families.
- Reached out to neighborhoods and Erin Braden will publicize events to our neighborhood.

Pedestrian Crosswalks

- The state is planning to install pedestrian crosswalks at the front of our neighborhood on Glendale and Ponce.
- Lines drawn indicate that they may dig up bushes near our signs we are awaiting some update and will watch closely.

City will Soon Shrink Commerce

- There are plans to shrink Commerce to 3 lanes in front of McDonald's.
- Cost is \$2.1 million dollars subsidized by the Path Foundation.
- Concerns were raised regarding bicycle lanes and changes proposed, as there will likely be unintended consequences of traffic on Church. Glendale may become a cut-through.

258 Forkner Townhouse Development

- There were significant changes to the original design to accommodate for guest parking.
- There is now a 5 ft rather than 8 ft sidewalk, and there is no current word on plans/timelines.
